TERMS & CONDITIONS

5. Should the available points not meet the points required for a particular reward item the cash top-ups will be permitted at the expense of the programme member.
6. The Programme Partners will keep a record of member's sales figures and reward points earned. Members will be sent a monthly statement showing how many points have been earned and/or redeemed.
7. Points may be claimed at any time subject to members following the correct claim procedures. No minimum points requirement will be imposed.
